2. Composition/Information on ingredients.

A dry cellulose based non-woven construction laminated together by EVA adhesive, and containing sodium percarbonate and tetra acetyl ethylene diamine powder particles.

3. Hazard Identification.

Oxidising agent contained in the construction.
Peracetic acid is generated on wetting.

4. First Aid Measures

Inhalation Not applicable

Eye contact Not applicable for non-woven construction. For liquid produced on wetting with water, in case of eye contact, flush eyes with running water for 15 minutes. Seek medical assistance.

- Skin contact** Dry non-woven construction is safe to handle, but gloves should be worn if products are handled on a regular basis. If skin is in contact with liquid produced on wetting with water, wash the affected area with running water. Remove affected clothing. Seek medical assistance if skin becomes painful, bleached or reddened.
- Ingestion** Ingestion of non-woven construction is unlikely. If it should occur, remove any material blockage, rinse mouth thoroughly with water. Seek medical assistance.

In case of fire extinguish with copious quantities of water.

Store in a clean and dry cupboard in packaging provided. Store out of direct sunlight. Keep away from heat sources. Store below 40 degrees Celsius. Avoid contact with water or humidity.
